

INTRODUCTION

Section 35.2 of the Forest Act enabled the *Tree Farm Licence Management Plan Regulation* November 27, 2009 which describes the approval process, term, timing, content requirements and public review process for a Tree Farm Licence Management Plan (TFL MP). The following sections present the required content for Tolko Industries Ltd.'s TFL 49 in accordance with the *Regulation*.

GENERAL DESCRIPTION OF TFL 49

Tree Farm Licence No. 49 (TFL 49) is held in the name of Tolko Industries Ltd. (Tolko) of Vernon B.C. BC Timber Sales also has volume apportioned within TFL 49.

Location

TFL 49 is located west of Okanagan Lake and covers approximately 110,426 ha (see Figure 1). The TFL was designated as a result of an amalgamation in 1984 of Tree Farm Licences No. 9 (Block A), No. 16 (Block B), and No. 32 (Block C). Management on this area-based licence has been conducted for over 60 years. Block A is situated west of Okanagan Lake to the height of land between the Okanagan and Nicola drainages, and north of Lambly Creek, to the Shorts Creek drainage. Block B runs west of Bouleau Lake, bounded on the south by the Salmon River drainage, to Salmon Lake, north to Monte Lake and west to the Monte Hills and Weyman Creek drainage. Block C is separate from the rest of the TFL. It is located north of Falkland and east of Pillar Lake towards the Salmon River.



HISTORY OF THE LICENCE

The *TFL MP Regulation* requires a brief history of the licence encompassing the period of time from the date the TFL was first issued to the date the MP is submitted to the Chief Forester.

History

Tree Farm Licence 49 was designated as a result of the previous Licensee's application of June 4, 1984 to amalgamate Tree Farm Licences 9, 16, and 32. The amalgamated Licence, referred to as the Okanagan Tree Farm Licence, has a 25-year term, beginning July 1, 2010.

The licence to manage the former Okanagan (West) Forest Management Licence (No. 9) was granted to S. M. Simpson Ltd. under a contract with the Province of British Columbia on August 16, 1951. The Licence was subsequently designated the Okanagan (West) Tree Farm Licence (No. 9) following amendments to the Forest Act. On December 1, 1970, S. M. Simpson Ltd. was acquired by Crown Zellerbach Canada Ltd.

Tree Farm Licence No. 16 (the Monte Lake Tree Farm Licence) was first granted to Pondosa Pine Lumber Company Ltd. on April 22, 1954. On December 1, 1970, Pondosa Pine Lumber Company Ltd. was acquired by Crown Zellerbach Canada Ltd.

Tree Farm Licence No. 32 (the Bolean Tree Farm Licence) was granted to Vernon Box and Pine Lumber Company Ltd. on June 29, 1959. Vernon Box and Pine Lumber Company Ltd. was purchased by Armstrong Sawmills Ltd. in 1964, but no formal merger took place. In 1969, Crown Zellerbach Canada Ltd. purchased Armstrong Sawmills Ltd. and in December 1970 Tree Farm Licence No. 32 was registered in Crown Zellerbach Canada's name.

On March 30, 1983, Crown Zellerbach Corporation sold its interest in Crown Zellerbach Canada Ltd. to Fletcher Challenge Limited of New Zealand. As a result of the ownership change, Crown Zellerbach Canada Ltd. was renamed Crown Forest Industries Limited (CFIL), effective October 1, 1983.

Fletcher Challenge Limited subsequently acquired a majority interest in British Columbia Forest Products Limited, and on September 2, 1988, its shareholders approved a name change from British Columbia Forest Products to Fletcher Challenge Canada Limited (FCCL).

Coincident with the change of name was the implementation of a management agreement between FCCL and CFIL, whereby FCCL agreed to manage the assets and business of CFIL. The collective corporate entity was known as FCCL, and included the operation and management of TFL 49.

On November 14, 1992, certain assets of Fletcher Challenge Canada Limited, including the rights associated with Tree Farm Licence 49, were acquired by Riverside Forest Products Ltd. Riverside Forest Products Ltd. subsequently was organized as a public company. Tolko Industries Ltd. purchased Riverside Forest Products in November, 2004 and is the current agreement holder for TFL 49.

Consolidations and Subdivisions

Consolidations, subdivisions, withdrawals, alienations and boundary changes to TFL 49 are listed in the following tables. Section 5(b)(iii) of the *Regulation* requires a list of all the boundary changes to the tree farm licence area involving over 200 hectares and the date of those boundary changes.

PLANNING DOCUMENTS

The *TFL MP Regulation* requires the title and description of each publicly available planning document used to guide forest management and operations of the TFL holder.

Publicly Available Planning Documents

The following planning documents are available to the public:

Tolko approved Forest Stewardship Plan #684 effective January 30, 2019 <u>BC Southern Interior Forest Stewardship Plan | Tolko Woodlands</u>. This FSP is a multi licence, multi agreement holder FSP that includes all of Tolko's Southern Interior Woodlands licences. Forest Development Unit FDU 4 – TFL 49 covers the TFL 49 landbase area. This FSP includes Results, Strategies and Measures consistent with the objectives set by government for the applicable resource objectives found within the Forest Development Units of the FSP. It also includes Stocking Standards for reforestation activities.

Okanagan Shuswap Land and Resource Management Plan (OSLRMP) was approved by Government in January of 2001. The OSLRMP provided government policy direction on the management natural resources for Crown Land in the plan area. Effective March 1, 2007, a Land Use order was made under the Land Act that brought the main forestry parts of the OSLRMP into legal objectives requiring corresponding Results and Strategies in FSP's for the following:

- 1. Marten Areas
- 2. Fisher Areas
- 3. Bighorn Sheep Areas
- 4. Forest Road Construction
- 5. Enhanced Riparian Management Zone Retention
- 6. Enhanced Riparian Reserves
- 7. Basic Levels of Coarse Woody Debris Areas
- 8. Basic and Enhanced Levels of Coarse Woody Debris Areas
- 9. Tourism Areas Foreground Visual Quality
- 10. Intensive Recreation Areas
- 11. Regionally Significant Trail Corridors
- 12. Community/Crown Interface

Numerous Government Action Regulation or GAR Orders are in effect on TFL 49. These GAR orders have been for two main categories:

- 1. Winter Ranges; and
- 2. Fisheries Sensitive Watersheds (Shorts Creek).

Winter Ranges are for listed species of wildlife with corresponding General Wildlife Measures. The General Wildlife Measures are non-FSP FRPA practice requirements and Tolko must follow them if forest management activities are conducted within the specific winter range areas on the TFL including the GAR Orders for Mule Deer (UWR U-8-001), Moose (U-8-006) and Mountain Goat (UWR U-8-005). WHA's have been established for Interior Western Screech Owl (WHA U-8-126), the notice includes an exemption from preparing a result or strategy.

Establishment of *Fisheries Sensitive Watersheds* with corresponding objectives such as the Shorts Creek FSW on the TFL have been established by GAR Orders. This GAR order contains specific objectives for the management of fish and fish habitat and Tolko has approved Results and Strategies in FSP 684.

Certification Schemes – TFL 49 is managed under the *Sustainable Forestry Initiative (SFI)* certification scheme which includes the SFI 2022 Forest Management Standard and the SFI 2022 Fiber Sourcing Standard. Tolko is also PEFC Chain of Custody certified.

TIMBER SUPPLY ANALYSIS

The *TFL MP Regulation* states the management plan must contain a timber supply analysis that analyzes the short and long-term availability of timber for harvesting in the TFL including the impact of management practices on the availability of timber. The Regulation also requires supporting documentation for the timber supply analysis including resource inventories, a description of the model and analytical methods used to formulate the timber supply and any other information relevant to timber supply on the TFL.

Supporting Documentation for Timber Supply Analysis

Forsite is completing the Timber Supply Analysis for TFL 49. This includes an Information Package which describes the resource inventories, management practices and model description used in the upcoming analysis. The Information Package was accepted for use in support on the timber supply analysis by Forest Analysis and Inventory Branch April 12, 2023 and is included as Appendix I (Version 1.2 updated June 21, 2023) – TFL 49 MP #6 Information Package.

The timber supply analysis report has been completed and is included as Appendix II – TFL 49 MP #6 Timber Supply Analysis Report, Version 1.1, January 25, 2024 prepared by Rob Kennett, RPF of Forsite. The report contains an analysis of the short, mid and long-term timber supply availability for TFL 49 along with a description of the PATCHWORKS modeling software used in the analysis.

FIRST NATIONS AND PUBLIC REVIEW STRATEGY

A public review strategy was submitted to the Acting Regional Executive Director (RED) on March 23, 2021. The strategy was subsequently approved by the RED March 24, 2021. The following is a description of the First Nations and public review strategy for MP #6. A summary of comments received during the Review and Comment period from First Nations and Public on the draft Management Plan will be included in Appendix III.

Approved First Nations Review Strategy

The following process will be used to refer the MP to the following First nations that are within the TFL 49 boundary. The goal will be to identify First Nations interests and concerns prior to submission of the plan to the MoF. Tolko has spent a significant amount of additional time working with representatives of the Okanagan Nation Alliance (ONA) to understand the Syilx principles and develop the Syilx Scenario which is presented in the Timber Supply Analysis.

- 1. Letters and a copy of the draft Management Plan will be sent to each First nation by April 1, 2024. These letters will outline the purpose of the Management Plan, and will request a meeting to determine how to best include First Nations interests. Letters will be sent via email and/or various portals that have been set up by First Nations.
- 2. An e-mail reminder will be sent approximately 3 weeks prior to the end of each 60-day period if no response has been received.

Approved Public and Stakeholders Review Strategy

Section 5(f) of the *Tree Farm Licence Management Plan Regulation* requires a description of the strategy used to conduct the public review and a summary of the public comments received as a result of the public review. The Management Plan will be available to the general public and stakeholders primarily through the use of the Tolko Woodlands website https://tolkowoodlands.com/southern-interior/. The following process is used:

- 1. Tolko prepared a list of identified stakeholders and/or people operating a tenure overlapping TFL 49. For the Management Plan, letters were sent to stakeholders that outlines the purpose of the management plan, as well as a link to the website and the closing date for comments.
- 2. In order to communicate to the broader public, newspaper advertisements for the Information Package and Management Plan were placed in the Kelowna Capital News, Vernon Morning Star, West Kelowna News and the Lake Country Calendar Classifieds. The ads indicate that the information is available for a 60-day period for review and comment and Tolko website viewing location was provided (see Appendix III).



Documentation of Comments Received


Any comments received by Tolko prior to submission of the final management plan to the MoF will be documented in the plan (see Appendix III).


